I submit that the Correspondent, **Sri City Chinmya Vidyalaya, Sricity, Varadaiahpalem Mandal, Chittoor District** has submitted proposals for **No Objection Certificate to start Middle Class with CBSE Syllabus for classes I to VII English Medium at a stretch during the academic year 2013-2014 without aid** to the Mandal Educational Officer, **Varadaiahpalem.** The Mandal Educational Officer, **Varadaiahpalem** in the reference 2nd cited has submitted the proposals along with his detailed visit remarks discussing about the providing necessary infrastructural facilities and fulfillment of conditions as laid down in the G.Os cited and recommended for grant of **No Objection Certificate to start Middle Class with CBSE Syllabus for classes I to VII English Medium at a stretch during the academic year 2013-2014 without aid** in respect of the said school. According to the report furnished by the Inspecting Officer and with reference to the proposals received, the following are the submissions with regard to fulfillment of conditions governing to grant of Permission to the school.

The details of the visit remarks about the amenities provided by the Management as follows:

About the Educational Society:-

The said school is running under the Management of "**Madras Chinmaya Seva Trust, Chetpet, Chennai**", dt: **23.9.1987** which was registered under certificate of registration of societies Act XXI of 1860, by laws of the Educational Society along with memorandum of Association and rules are enclosed to the proposals.

Inspection Fee:-

As required in Rule 2(b) of the G.O.first cited read with the G.O.2nd cited, the management has remitted an Amount of Rs.10.000/- (Rupees Ten thousand only)

Recognition :-

The said school is enjoying renewal of recognition for classes I to VII EM from 2013-2014 to 2017-2018 without aid vide Proc.Rc.No:967/C3/2013, Dt: 07.02.2013 of the District Educational Officer, Chittoor. Xerox copy of the same is herewith enclosed to the proposals.

Endowment fund:-

The Management has purchased National Saving Certificate (NSC Bonds) at Sub Post Office, Varadaiahpalem for an amount of Rs.25,000/- vide NSC Nos are: 99 EE 831863, 99 EE 831864 for Rs.10000/- each and 65 DD 440039 for Rs.5000/- each dt: 26.10.2012. Xerox copies of National Saving Certificates, is herewith enclosed to the proposals.

Accommodation:-

The Correspondent, **Sri City Chinmya Vidyalaya, Sricity, Varadaiahpalem Mandal, Chittoor District** has provided 20 rooms for accommodation of school and provided separate room for Library & Staff room. The management of the School is its own i.e., from Madras Chinmaya Seva Trust which was registered vide Regn.No: 990/2012, dt: 06.09.2012 registered at Sub Registrar Office, Sathyavedu.

Sketch plan of the building is enclosed to the proposals. Photos of the school building, play area and class rooms, Lab, Library, Computer wing etc., are enclosed to the proposals. Hence the accommodation and school space provided by the management is adequate. There is no thatched sheds or rooms in the school premises and the management has provided fire prevention arrangements.

Play Area :-

The management has provided with an extent of vacant land for play ground purpose, which is annexed to the school building. Xerox copy of the document is herewith enclosed to the proposals. The vacant area provided for play ground is adequate as stipulated in Rule 5(7) of the G.O.first cited.

Furniture:-

The Correspondent of the School has provided adequate furniture for the staff and students i.e., HM, Office staff, Lab, Library and also students adequately. (List of furniture provided by the Management is enclosed.)

Library books:-

The management has provided 800 books for Library in different subjects viz. English, Hindi, Telugu, Mathematics, Science, Social, G.K. Books. (The list of library books provided is enclosed)

Laboratory:-

The Management has provided the Lab equipment adequately. List of lab equipment and documentary evidence of lab equipment is enclosed.

A.V.Equipment:-

The management has provided adequate A.V. Equipment in the school, (documentary evidence of A.V. equipment is enclosed.)

Staff:-

The management has appointed 14 qualified teaching staff members for the school adequately without following the recruitment procedure as per rules i.e., G.O.Ms.No: 1, Edn., dt: 1.1.1994. Particulars of teaching and non teaching staff working in the school along with their designation and qualifications and their provisional certificate (Xerox Copies) are herewith enclosed to the proposals. Hence, teaching staff appointed is adequate. Particulars of teaching staff are enclosed to the proposals.

Syllabus and Text books:-

The Management of the school is following the syllabus and text book as prescribed by the Govt. of A.P.

Fee and Pay structure:-

The Management has submitted the resolutions of Governing body fixing about the pay and fee structure as follows:

Soundness Certificate:-

The management has submitted the Structural Soundness certificate issued by Chartered Engineer, Chennai stating that the building is structurally sound enough to run the school purpose.

Sanitary certificates:-

The Correspondent has provided separate Urinals for Boys, Girls and Staff adequately. Sanitary conditions are satisfactory, having good lighting, Ventilation and maintaining very clean. The sanitary certificate issued by the Medical Officer, Primary Health Centre, Chinnapandur, dt: 3.4.2013 (Copy enclosed).

First aid kit:-

The management has provided first aid kits in the office room. (Photo copy enclosed)

Games Materials:-

The Management has provided adequate play materials in the school for the students (documentary evidence is enclosed.)

Zebra Crossings:

The said school is located far away from the main road. Hence there is no need for Zebra Crossing.

Maintenance of Vehicle :-

The Management has not maintained any vehicle to transport the children.

In this connection, I submit that the Mandal Educational Officer, **Varadaiahpalem** has requested to issue grant of **No Objection Certificate for Middle Class Syllabus of CBSE for classes I to VII English Medium at a stretch during the academic year 2013-2014 without aid in respect of "Sri City Chinmya Vidyalaya, Sricity, Varadaiahpalem Mandal, Chittoor District"** subject to fulfillment of conditions as prescribed in G.O. 1st cited.
